**Parking Lot Straight Salt:** (effective to -15°)

CHECK HERE if you require parking lot(s) & runways to be "Salted" (de-icing) for most plow-able snowfalls, for most snowfalls under 1(one) inch, and for most freezing (or re-freeze) type of precipitation that occurs. Priced at \$0.99 per pound applied (minimum \$147.00 per visit)
