Snow Plowing Contract – MONTHLY

CONTRACT DATES: November 1st, 2025 – March 31st, 2026

\$_____ .00 PER MONTH will be invoiced on the 1st of each month starting November 1st through March 1st (5 months total). This monthly charge covers 12 total snow events, over 1 inch of snow for the 5-month period.

**** Both prices stated are part of the total contract ****

\$_____ .00 PER SNOW EVENT will be invoiced for each snowfall over 12 total for the season (if applicable). This will be invoiced in April once the winter season has ended.

**** All prices above include “clearing the end of the driveway after the city plow clears the road”. C N'R will guarantee that the end of the driveway will be cleared each snow event needed. ****

1.00”-2.99” (C N'R system of operations)

C N'R will clear snow off of driveway(s) only 1 time after the snow has finished accumulating.

3.00” – 5.99” (C N'R system of operations)

C N'R will clear snow off of driveway(s) 1-2 times during the snow event. If the snow event requires 2 clearings, the first clearing will be an “opening” and the second clearing will be a complete plow.

6.00”-9.99” (C N'R system of operations)

C N'R will clear snow off of driveway(s) 1-3 times during the snow event. Until the final clearing is accomplished, all clearings prior will be “openings” of the driveway(s).

10.00”-13.99” (C N'R system of operations)

C N'R will clear snow off of driveway(s) 2-3 times during the snow event. Until the final clearing is accomplished, all clearings prior will be “openings” of the driveway(s).

14.00” & above (C N'R system of operations)

C N'R will clear the snow off of driveway 2-4 times during the snow event. Until the final clearing is accomplished, all clearings prior will be “openings” of the driveway(s).

Definition: “openings” = clearing a path from the road to the garage that may not be the total width of the driveway(s). This is to ensure that customers can at least get in and out of their driveway(s) through the duration of the snow event.

OPTIONAL SERVICES:

“Light Snow” Special Snowfall (0.50” – 0.99”) ----- \$_____ .00 / Snow Event

C N'R will clear snow off the driveway(s) only 1 time after the snow has finished accumulating. **This extra service will be charged in addition to the monthly price stated above and will not be applied towards the 12 snow events included in the monthly price.**

Driveway Straight Salt (effective to -15°) ----- **\$ 43.00** / Event

C N'R will apply SALT for most plow-able snowfalls, for most snowfalls under 1 (one) inch, and for most freezing (or re-freeze) precipitation that occurs. **** \$0.49 per pound of salt applied will be added to the total base price stated above ****

Fuel surcharges of 2.0% of the total invoice is added each month that fuel prices go above \$2.50/gallon, with an additional 0.5% for each \$0.25 thereafter.
